

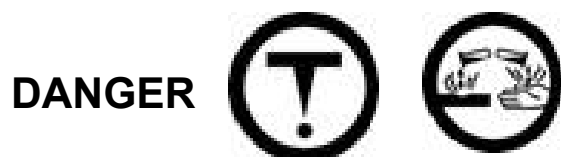


Water Conditioner

BEFORE HANDLING OR USING THIS PRODUCT, SEE YOUR EMPLOYER AND READ THE CURRENT MATERIAL SAFETY DATA SHEET

ACTIVE INGREDIENT

Ammonium Hydroxide: 9.75%



CAUSES SEVERE EYE BURNS•CAUSES SKIN BURNS•HARMFUL IF INHALED; MAY CAUSE LUNG INJURY•MAY CAUSE RESPIRATORY TRACT IRRITATION•ASPIRATION HAZARD. CAN ENTER LUNGS AND CAUSE DAMAGE.

Keep out of reach of children. Do not get in eyes, on skin, on clothing. Do not swallow. Avoid breathing vapor or mist. Wash thoroughly after handling. Keep container closed. Use with adequate ventilation.

FIRST AID

IN CASE OF EYE CONTACT, immediately flush eyes with plenty of water for at least 30 minutes. Remove contact lenses, if worn. Get medical attention immediately.

IN CASE OF SKIN CONTACT, immediately flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Get medical attention immediately. Wash clothing before reuse. Destroy contaminated shoes.

IF SWALLOWED, call a physician and/or transport to a medical facility immediately. Do NOT induce vomiting unless directed to do so by medical personnel. Never give anything by mouth to an unconscious person.

IF INHALED, remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, oxygen should be administered by qualified personnel. Get medical attention.

TOXICOLOGICAL INFORMATION

No specific antidote. Employ supportive care. Treatment should be based on judgement of the physician in response to reactions of the patient.

STORAGE

Keep in original container during storage. Store product in cool, dry, well ventilated place away from seed, feed, fertilizer, or other pesticides. Do not store in aluminum.

DISPOSAL

Do not reuse this container for any purpose. This is a recyclable container, and is to be disposed of at a container collection site. Contact your local distributor/dealer or municipality for the location of the nearest collection site. Before taking the container to the collection site:

1. Triple- or pressure-rinse the empty container. Add the rinsings to the spray mixture in the tank.
2. Make the empty, rinsed container unsuitable for further use.

If there is no container collection site in your area, dispose of the container in accordance with provincial requirements.

For information on disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory agency. Contact the manufacturer and the provincial regulatory agency in case of a spill, and for clean-up of spills.

MIXING INSTRUCTIONS

1. Fill sprayer tank 1/2 full of water and continue filling while adding products to the tank.
2. Start sprayer tank agitation and continue agitating throughout filling process.
3. Add 1.5 L of Water Conditioner per jug of Simplicity to be mixed in the spray tank.
4. Follow the mixing instructions on the product label.
