



Intrepid Edge® insecticide combines fast knockdown and lasting residual activity for proven results. Two modes of action deliver effective control against destructive, yield-robbing insects like corn earworm, true armyworm and more.

Corn (Field, Popcorn & Seed)

Target Pests	Rate (fl oz/A)	Application Timing
Armyworm, True Corn borer, European, southwestern Cutworm, Western bean Sugarcane borer	4 - 12	Scout for corn borers and armyworms with enough regularity to monitor egg laying and egg hatch. Apply at first sign of egg hatch (field corn), feeding damage (sweet corn), or when infestations reach threshold levels as defined by a cooperative extension service or other qualified professional authorities. For control of first generation European corn borer and armyworms, direct application at the whorl for early season (first generation) infestations. Apply as broadcast or multi-nozzle over the row application to mid- and late season infestations. Under heavy infestations, continuous moth flights, or rapid crop growth and development, reapply at 5- to 10-day re-treatment interval.
Corn earworm	8 - 12	For control of corn earworm, apply broadcast or direct spray to ear zone. Use sufficient spray volume and nozzle pressure to ensure thorough wetting of the silks. A 2-day re-treatment schedule may be necessary at silking.

Max Rate Applied Per Year: 32 fl oz/A (0.625 lb methoxyfenozide, 0.125 lb Jemvelva)
